AGREEMENT ON COOPERATION

between

the Belarusian State University and the Universidad Privada Boliviana (Bolivia)

The Belarusian State University, Minsk (Belarus) and the Universidad Privada Boliviana, Cochabamba (Bolivia), hereinafter referred to as the "Parties", have signed the present Agreement for the development and strengthening of international relations in the field of education, science and technology.

Clause 1

Enjoying equal rights and proceeding from mutual interests, the Parties agree on the following forms of cooperation:

- exchange of students, masters, post-graduate students, doctorants for instruction, practical training and research studies;
- invitation of the representatives from both Parties to lecture, exchange opinions and experience, to share information on working and educational methodology, training programs and scheduling;
- joint research, conferences, workshops, other scientific arrangements and events;
- publication of research, educational and methodological materials resultant from joint activities;
- interlibrary exchange including specialized scientific-and-technical, scholarly and methodological literature, periodicals.

Clause 2

At the time of signing the present Agreement the Belarusian State University is represented by the Physics Faculty, and the Universidad Privada Boliviana is represented by the Center of Optical Research. By mutual consent of the Parties, this Agreement may be acceded to by other structural divisions of the Belarusian State University and the Universidad Privada Boliviana.

The Parties come to an agreement that establishment of direct contacts between the parties interested in particular fields is an optimum way for realization of cooperation.

Both parties agree that this agreement does not involve any financial responsibility.

Clause 3

Within the present Agreement other forms of cooperation are possible after separate negotiation by the Parties.

All alterations and amendments to the present Agreement are possible only by written notice of the Parties.

Clause 4

The present Agreement comes into force from the date of signing by authorized representatives of the Parties.

The present Agreement is valid for a two-year period time and the two institutions may agree to renew it for another two years. It may be terminated any time by mutual consent or by nine-month notice in writing by either Party.

Clause 5

Cooperation of the Parties within this Agreement should be realized following the current legislation of Belarus and Bolivia.

Signing of the present Agreement with possible addenda may be effected by fax. Fax reproduced signatures and official stamps are legally valid. Presentation of the original documents by the Parties is due within one month after the signing.

The Agreement is drawn up in duplicate in the English language.
