

Student Exchange Agreement
between
Belarusian State University
and
Chungbuk National University

Considering the success of the exchange program and desiring to develop and strengthen mutually advantageous relations the Belarusian State University represented by its Rector Sergey V.Ablameyko and Chungbuk National University represented by its President Seung-Taik Kim, hereinafter referred to as Parties, reached the following student exchange Agreement:

1. Exchange organization

1.1. Every year each Party sends 2 students for training at the partner university. The number of students in a particular year may exceed two, but the Parties undertake to balance the numbers of students every five years.

1.2. Duration of study is one or two semesters.

1.3. Training is carried out in accordance with the regular curricula and programs of the host university. After completing of the prescribed study course, the certificate for the acquired credit and study result will be granted from the host Party. The home Party will then consider this certificate according to the rule of each for qualifying.

1.4. All students participating in the exchange must comply with the legislation of the host Party, as well as regulations in force in the host university.

2. Student selection

2.1. Selection of applicants who intend to participate in an exchange shall be made by the home Party. The host Party shall consider the submitted documents and issue invitations in case of approval.

2.2. The exchange students shall be selected on the basis of academic merit. The main selection criterion is the language proficiency (Russian for CBNU students and Korean for BSU students).

2.3. The name of exchange students and data shall be sent to the host university before May 30 or November 30 annually.

3. Terms of exchange

3.1. The host Party should release the exchange students from admission, tuition and accommodation fees.

3.2. The home Party or exchange students should cover all the international travel expenses, medical insurance and so on.

3.3. Students participating in the exchange use the dormitories, classrooms, equipment, libraries, reading rooms, teaching aids and materials, sports and cultural facilities of the host university that are normally available to regular students.

4. Concluding provisions


4.1. The Agreement is valid for a period of 5 years and is effective on the date of signing. It will be automatically renewed for the next period if neither Party terminates this Agreement by written notification of another Party not later than 3 months before the period of validity of the Agreement is over.

4.2. The termination of this Agreement shall not affect the ongoing exchange program.

4.3. Carrying out activity within the framework of the present Agreement, the Parties will observe the legislation of Korea and Belarus. Disputes arising under this Agreement shall be resolved through negotiations between the Parties.

4.4. This Agreement has been signed in two identical copies in English.


