

**AGREEMENT ON STUDENT EXCHANGE
BETWEEN
UNIVERSITY OF ULSAN, REPUBLIC OF KOREA
AND
BELARUSIAN STATE UNIVERSITY, REPUBLIC OF BELARUS**

Based on the "Memorandum of Understanding for Academic Exchange between University of Ulsan, Republic of Korea and Belarusian State University, Republic of Belarus," both parties agree to conclude an agreement as specified in the following articles to facilitate smooth implementation of the student exchange pursuant to Section 1 (2) on the basis of Section 2.

1. Number of Students
The number of exchange students at each party shall not exceed 2 students per year.
2. Length of Stay
The length of stay shall in principle be less than one year. However, if both parties agree, it is possible to extend the stay for one more year.
3. Tuition and other Fees
Exchange students are not required to pay examination fees, entrance fees and tuition fees at the host university.
4. Transfer of Credits
The home university will be responsible for the credit transfer.
5. Housing
Each party will endeavor, to the best of its ability, to assist students with securing suitable housing. Payment of rent, if required, and other housing-related fees will be the sole responsibility of the student.
6. Insurance
All exchange students must have sufficient insurance coverage during their stay in the host country. The type of insurance may vary according to the length of their stay. Each party is responsible for advising the student as to what kind of insurance is required.
7. Non-Discrimination
Both parties subscribe to the policy of equal opportunity and do not discriminate on the basis of race, sex, age, ethnicity, religion, sexual orientation, national origin or disability. Both parties shall abide by these principles in the administration of this agreement.
8. Term
This agreement becomes effective on the date of _____ and is valid for an initial period of five years. It can be amended by the written consent of both parties. It can be renewed, by mutual agreement in writing, for another five years. It can be terminated by either party by giving a notice of termination in writing no less than six months in advance.
9. Dispute Settlement
Questions or concerns regarding the terms set forth in this agreement shall be resolved through consultation as the need arises. Both parties agree that they shall endeavor to settle any dispute relating to this agreement by negotiation with each other in good faith.

10. Privacy and Personal Information

Both parties agree to collect, process, use, disclose, and otherwise manage personal information only for the purposes of fulfilling their obligations under this agreement.

11. Notes

This agreement is prepared in English. Two signed copies will be prepared and both parties will keep one of each.
