

**Academic Agreement  
between  
Belarusian State University  
and  
University of Warsaw**

**The Belarusian State University** (hereinafter referred to as "BSU"), with its seat in 4 Nezavisimosti Ave., 220030 Minsk, Belarus, represented by its Rector Prof. Sergey V. Ablameyko, and **the University of Warsaw** (hereinafter referred to as "UW"), with its seat in 26/28 Krakowskie Przedmieście st., 00-927 Warsaw, Poland, represented in this act by its Rector, Prof. Marcin Pałys, (hereinafter referred to as "parties") establish hereby a formal understanding of cooperation and friendship which is intended to further the academic objectives of each institution and to promote better understanding between the faculty and students of the UW and the faculty and students of the BSU.

Under this Academic Agreement the two institutions will proceed to implement the following endeavours:

**§ 1  
Areas of cooperation**

Cooperation shall be carried out, subject to availability of funds and the approval of the competent authorities of the UW and BSU, through such activities or programs as:

1. Joint European research projects;
2. Exchange of faculty members for short-term internships;
3. Exchange of students for short-term studies;
4. Exchange of students for training at all levels (BA, MA, PhD);
5. Joint research activities;
6. Participation in seminars and academic meetings;
7. Exchange of academic materials and other information;
8. Exchange of Administrative Managers/Coordinators;
9. Joint cultural programs.

Terms of such mutual cooperation and necessary budget for each specific program and activity that is implemented under the terms of this Agreement shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of the particular program or activity.

Both Parties understand that all final arrangements will have to be negotiated and will depend on the availability of funds.

§ 2

**Scope of the Cooperation**

Areas of cooperation include, subject to mutual consent, programs offered in English, Polish and Russian at either university as felt desirable and feasible on either side and that both sides feel can contribute to the fostering and development of the cooperative relationships between the two universities.

The assistance to be provided by each of the contracting parties will be teaching, research, exchange of faculty members and students, staff training, etc. as deemed beneficial by the two institutions.

§ 3

**Implementation**

The present Agreement shall remain in force for a period of five years from the date it is signed by the legal representatives of the two universities. It may further be extended or amended upon a written consent of both parties. This Agreement may be terminated by either party subject to delivery of six month advance notice, in writing.

BSU designates Ms. Ludmila Gonchar, (International Relations Office) E-mail gonchar@bsu.by, as a coordinator and contact person with regard to implementation of the present Agreement.


