This Memorandum of Understanding (MOU) sets for the terms and understanding between the FSES CU, Law Faculty CU and the FIR BSU to establish closer cooperation in research, education and projects in area of international relations, European affairs and law.

1. Background

On behalf of the education and research profile of all partners, cooperation on projects in area of international relations, European affairs and law there is drafted the memorandum to formalize institutional relations.

2. Purpose

2.1. The main purpose of the Memorandum is to promote the development of the Partner universities through the advancement of education and research in the field of the European integration studies and active participation in the implementation of the corresponding academic projects and programs.

2.2. The above goals will be accomplished by undertaking the following activities:

- exchange of undergraduate, graduate and postgraduate students for education, probation period and training practice;
- visits of the parties' research staff for delivering lectures and conducting practical studies, sharing experience and information on scientific and methodical work, curriculum and programs;
- joint scientific research, conferences, seminars and other scientific events;
- publication of the results of the joint scientific, training and methodical work.

3. Reporting

The Parties shall make the annual evaluation of the progress achieved in the sphere of the academic cooperation within the scope of this Memorandum and coordinate further specific actions to ensure its effectiveness.

4. Funding

- 4.1. This MOU is not a commitment of funds. Every particular activity has to be regulated by separate protocol, including the budget and the financial contribution of each partner.
- 4.2. There is possible establish individual cooperation and funding protocol for particular research areas between individual partners.

5. Duration

- 5.1. This MOU is at-will and may be modified by mutual consent of authorized officials of partners.
- 5.2. This MOU shall become effective upon signature by the authorized officials from all partners and will remain in effect until modified or terminated by any one of the partners by mutual consent.
- 5.3. In the absence of mutual agreement by the authorized officials of all partners this MOU shall end at the end of the second month from delivery of the written withdrawal to the partners.




